Tuesday December 14th, 2021 Meeting Minutes

Review of minutes from the Tuesday November 16th regular meeting and budget meeting . Motion to accept minutes as read by Tony Johanik, seconded by Skip Radosevich. Motion carried.

Carol Pufall, Town Treasurer, gave overview of town's finances. \$19,783.43 in checking account, \$22,666.56 in money market, \$40,512.69 in special project account, \$22,839.33 in ARPA checking account. Transferred \$500 from money market to a new business savings account which now has a balance of \$2,550.05. Tax bills have been sent out and were a little higher than last year. More snowplow contracts came in, distributed new lists.

Skip Radosevich, Town Supervisor, Lights fixed at town hall including new brighter bulbs. Found the old blueprint layouts of town hall and all of its sewer lines. Will plan to show Norvado prior to them digging/installing new fiber optic line. Mentioned propane bill for garage seems to be high and offered the idea of additional insulation.

Tony Johanik, Town Supervisor, Kelly truck is complete and looks great. The L9000 is getting new tires. The new Dodge 1-ton had to have water pump, belt, tensioner and DEF sensor fixed. Some disappointment with new salt spreader on 1-ton since salt cannot be left in it overnight. Will have to work out ways to regulate amount of salt put in prior to each use.
