Tuesday July 13<sup>th</sup>, 2021 Meeting Minutes

**Meeting called to order at 6:00 pm by Marty Milanowski, Chairperson. Pledge of Allegiance recited.**

**Review of minutes** from the Tuesday June 8<sup>th</sup> regular meeting. Motion to accept minutes as read by Skip Radosevich, seconded by Tony Johanik. Motion carried.

**Carol Pufall, Town Treasurer**, gave overview of town's finances. \$57,183.28 in checking account, \$100,153.96 in money market account, \$40,511.01 in special project account, 36,215.32 in new ARPA checking account. Asked if town would be interested in new business account special allowing up to \$120 bonus earnings.

**Skip Radosevich, Town Supervisor**, Reviewed bid from Jerry Peterson for town hall bathroom remodel. Motion to proceed with project made by Marty Milanowski, seconded by Tony Johanik.

**Tony Johanik, Town Supervisor**, New dump box purchased for Kelly truck instead of repair. The John Deere tractor is in need of repair (pops out of gear). Purchasing service manuals so repair can be made. Culvert installed on Then Rd. and weeds sprayed by Nemec & on Franzel Rd.

**Joe Mattson, Town Clerk**, Stated new ARPA account is set up in quickbooks and have received debit card and checks for ARPA approved purchases.

**Old Business:** Discussed proceeding with Carlson Rd. LRIP project after changing from Terwilliger Rd. A new ad required for bid of Carlson Rd. prior to starting project. Joe to place ad in paper after Marty gets him the specs.

**New Business:**

- Review driveway permit for Terry Torkko - Approve/Disapprove.  
Marty sending Randy to review driveway with Terry Torkko on site, with tentative approval based on Randy's recommendation after review.
- Discuss new building code inspector for the town.  
New inspector: Robert Lietha (Inspector Rob Agency LLC) 218-393-6482. Will be adding contact info to town website.
- Discuss ARPA (American Rescue Plan Act) funds & account  
Half of funds received in the amount of \$36,215.32 and new account set up for specific fund. 2nd half expected in 2022. The town has until the end 2024 to engage in contractual

agreements for fund spending and until the end of 2026 to use funds. Will need to follow specific rules for what funds can be used on.
