Meeting Minutes

7:00 pm @ Bayfield County Business Park

Meeting called to order at 7:00 pm by Marty Milanowski, Chairperson. Pledge of Allegiance not recited as it had just been recited at the elector meeting beforehand.

Review of minutes from the June 11th, board meeting. Motion to accept minutes as read by Tony Johanik, seconded by Skip Radosevich. Motion passed.

Carol Pufall, Town Treasurer, read the treasurer report. Next large deposit will be from taxes and will be received by August 15th. Every town resident has paid their tax bill currently.

Skip Radosevich, Town Supervisor, shared that the ditch and tree clean up went well and looks good at the town hall. A bill will be coming for this. Verified that the address he gave for the bill was the town garage at 29130 State Hwy 137.

Tony Johanik, Town Supervisor shared that the exhaust was fixed on the L9000 and is finished and the John Deere is back from Don's. Also discussed that the Peterson Pit is now open so will talk to Ryan about getting gravel delivered.

Crystal Mattson, Town Clerk, shared that the town has received one FEMA check in the amount of \$5173.09 and that she attended a meeting at Bayfield County to discuss the other projects in the Grants Portal. There is currently one project showing completed and is just waiting to be sent for payment. This is one of the larger checks totaling over \$100,000.

Old Business:

New Business: Sign Placement request for the **Eileen Area Historical Society** was presented by Terry Torkko. Terry shared that there is 1 acre of property deeded to the town by the City of Ashland in 1956 and deemed to be used for municipal community purpose. Terry stated that this is right in line with the request for the historical society. The sign would be near the old Highland School which currently has 3

monuments: One for Herbert Heglund, one for Donald Anderson and one for Leonard Wilhelm. There is an existing sign in this place in which the Historical Society would like to remove and replace with a "V" sign stating Highland Area Veterans Memorial Sponsored by Eileen Area Historical Society. Terry requests approval from the board to place the sign and to have someone sign the permit for this. A motion was made by Skip Radosevich to allow the Historical Society to proceed with sign placement, Tony Johanik seconds. Motion passed. Terry to bring permit to clerk to be signed when completed.

Discussion of Woodland Road and Xcel Energy- Xcel Energy trucks had been turning down Woodland and eating up the gravel on the road. Xcel Energy was contacted and they brought 6 loads of gravel to replace and graded. They will let the town of Eileen as well as the town of Gingles know if they are doing work in the future.

Board discussed town picnic and due to funds right now, decided that they would skip this year. Clerk to place notice in paper letting residents know as well as online on the website.
