Review of minutes from the May 14th, 2019, board meeting. Motion to accept minutes as read by Tony Johanik, seconded by Marty Milanowski. Motion passed.

Carol Pufall, Town Treasurer, read the treasurer report.

Skip Radosevich, Town Supervisor, shared that the town will be paying \$1200 to Mark with Quality Tree Service to cut down and haul away some trees at the town hall. One is dead and the others are in line with the power lines so making sure we won't have any issues in the future. Skip also shared that we have a resident complaining of dust control on Colby Rd, however explained that because FEMA reimbursement is still in process we will not be providing dust control at this time due to lack of funding.

Tony Johanik, Town Supervisor shared that the tractor was just in at Don's Repair for the AC system. Had to do with a charge.

Crystal Mattson, Town Clerk, stated that the board needs to make sure we budget anywhere from \$7500-\$10,000 for new election equipment after the 2020 presidential election.

New Business: Discussed conditional Use permit for Derek Marincel to do a mound system and build a home on Hagstrom Rd. Tony made a motion to approve the permit, Skip seconds. Motion carried.

Marty discussed town projects. Black top on culvert projects is completed. Next is working on Vernor's culvert. Also still need to do culverts on Hnath's Rd and Zeczyk. There is a washout by Larson Creek and the town still needs to complete the culvert on Range Rd. Will be splitting with Town of Pilsen and county.
